# HOW TO APPLY

## CALLS FOR PROPOSALS

- 1** Publication of calls for proposals on the Funding and Tenders Portal (FTP) and HaDEA website
- 2** Submission of proposals via the FTP:
  - Fill in part A online (administrative form)
  - Download the templates for part B (technical narrative & the detailed budget table)
  - Submit the full proposal within the deadline
- 3** Evaluation by HaDEA
- 4** Information letters sent to (un)successful applicants
- 5** Grant agreement preparation with successful applicants
- 6** Grant signature, accession of partners and start of the project

## CALLS FOR TENDERS

- 1** Publication of calls for tenders on TED eTendering and HaDEA website
- 2** Submission of the offer on the call page through e-submission
  - Read the tender specifications and related annexes (procedure, requirements and criteria)
  - Draw up the technical and financial offer (no dedicated template available)
  - Submit the offers within the deadline
- 3** Evaluation by HaDEA
- 4** Information letters sent to (un)successful tenderers
- 5** Contract signature and publication of the contract award notice
