1. FRAMEWORK OF THE PROPOSAL

1.1. Title of the proposal

Establishing the "European Health and Digital Executive Agency".

Delegating powers to the European Health and Digital Executive Agency with a view to the performance of tasks linked to the implementation of European Union programmes in the field EU4Health, Single Market, Research and Innovation, Digital Europe, Connecting Europe Facility – Digital, comprising, in particular, implementation of appropriations entered in the general budget of the Union.

1.2. Nature of the proposal

RESULTS OF THE COST – BENEFIT ANALYSIS

1.4. The scenarios - Global results

Scenario 1: Status quo scenario, where all six existing agencies keep their current portfolio of programmes. When comparing the status quo scenario with the ideal allocation criteria, some issues can be observed:

- 1) With respect to Horizon Europe new structure, the implementation of several Clusters (Cluster 2, 3, 4, 5 and 6), as well as the implementation of the European Innovation Council, are split between two agencies.
- 2) The climate-related and environment-related programmes (a.o. Innovation Fund, LIFE, Horizon Europe's Cluster 5: Climate, Energy and Mobility) are spread between two agencies. They do not constitute the focus of either agency, and are therefore not visible, despite the importance of this theme.
- 3) Similarly, the digital activities (CEF Digital, Digital Europe Programme, Horizon Europe's Cluster 4 "Digital, Industry and Space") are split between two agencies, weakening the visibility and focus of the Digital theme.
- 4) The issues identified in respect of CHAFEA are not addressed, except partly the size, which would increase but would remain too small.

Scenario 2: Optimised scenario, in which it is proposed to create a strong Health and Digital portfolio grouping the Health programmes with the various Digital programmes, as well as the Food Chain strand of the Single Market programme.

Combining the EU4Health programme and the Health cluster from the Horizon Europe with the newly delegated activities from DG SANTE (food safety) will ensure a coherent implementation of the portfolio of Health-related programmes/cluster/strand. Indeed, the new Executive Agency will provide for continuity of various previous actions while streamlining and exploiting synergies between them and with new activities, aiming to prevent duplication and fragmentation in its support for the internal market. It aims to provide tools to support Member State efforts to recover, repair and emerge stronger from the crisis.

Separately, the grouping of Horizon Europe's cluster "Digital, industry and space" as well as the Connecting Europe Facility's digital strand and the new Digital Europe Programme will create a strong digital focus.

The combination of an important Health portfolio with a substantial Digital portfolio will provide for an efficiency gains in both domains and ensure the mutual enhancement of their implementation.

Furthermore, all delegated activities of DG SANTE and DG CNECT will be grouped in this agency, thus facilitating the coordination between DGs and executive agencies.

In-house scenario

The in-house scenario would imply:

- re-internalisation of legacy contract management after the winding-up of the existing agency for the programmes already delegated to EASME / CHAFEA / INEA in the current MFF;
- finding adequate resources for implementing the new programmes in the next MFF e.g. Digital Europe or programmes with a very significant budget increase e.g. CEF Digital;

- additionally, the same DGs would need to implement the budgets for programmes managed in house in the current MFF e.g. H2020.

To optimize the efficiency and quality of the implementation; the Commission considers to carry certain tasks *in-house* and to delegate other tasks to implementing bodies. The Commission will be in charge of all key decisions, including the strategic planning, launch and the design of the calls for proposals for the parts of the programmes delegated to the agency. On the other hand, the executive agencies have the knowledge and competence for the efficient organisation of EU grant programmes.

Preferred scenario:

Scenario 2

Based on the above analysis of the delegation scenarios, the preferred solution is to delegate the implementation of relevant parts of the EU4Health, Food Chain strand of the SMP, Digital Europe, CEF Digital and clusters 1 and 4 of Horizon Europe programmes to the Agency, effectively achieving the necessary synergies. This will also aim to ensure higher administrative efficiency while fully addressing the key recommendations of the Court of Auditors.
