- **SYNERGIES** with CR-g-22-08.01 Direct grants to Member States' authorities: Cancer and other NCDs prevention – action on health determinants – **SUBTOPIC ON CANCER**
- An ambitious Joint Action to support actions to prevent non-communicable diseases and cancer
- A new approach to support coordinated actions in the area of health promotion and disease prevention
- Two subtopics contributing to health promotion and NCDs prevention through synergies of existing EU health policies and mechanisms
- Creation of the 'EU Consortium on Cancer Prevention'

- **SYNERGIES** with EU4H-2021-PJ-18 project grant wave 2 on supporting the usability of the EU mobile application for cancer prevention, which will be developed under the tender HADEA/2022/OP/0004 to design, develop, pilot and deliver an ‘EU Mobile App for Cancer Prevention’
 - The software and the app developed will help to ensure a better coverage and access to counsels and recommendations, on how to reduce the cancer risk. The main deliverable of the tender, called ‘EU Mobile App for Cancer Prevention’ will be offered for free to the general population, to individuals at higher cancer risk and to difficult-to-reach populations, and will include, inter alia, the recommendations of the European Code against Cancer

Call for proposals: cancer and other NCDs prevention - on health determinants

- Annual work plan 2022
- EUR 11 million (for the two subtopics)
- Aim: address common health determinants
- Subtopic 1: cancer prevention (EUR 8 million)
- Subtopic 2: non-cancer specific NCD prevention (EUR 3 million)

Objectives

- To complement the implementation of the joint action on 'Cancer and other NCDs prevention – action on health determinants'

- supporting the Europe's Beating Cancer Plan and policy initiatives on NCDs.

Activities

- Complementing the Member States' efforts in the design, planning and implementation of best practices
- Production of public health guidelines
- Patients' and caregivers' consultations or other actions that can benefit citizens directly
- Preparation and roll out of innovative practices (pilot test)
- Support actions such as training and twinning
- Health communication or health literacy.
