#### Main objectives of the JA:

- The JA will support the policy objective of reducing the burden of cancer and other NCDs and implements the EU4Health Programme's general objective of improving and fostering health
- The aim of this JA is to reduce the burden of cancer and other NCDs and common risk factors, both at a personal and societal level, and support Member States by taking a holistic approach for the prevention of cancer and other NCDs, through providing a decisive boost for coordinated action
- In the context of the Europe's Beating Cancer Plan and of the need to address NCDs, the JA will address:
  - health determinants common to cancer and other NCDs
  - their common underlying risk factors, avoiding fragmentation of actions, duplications and overlaps, promoting engagement of Member States, and increasing impact

## Health in all policies and governance

- Building supportive structures for comprehensive and cross-sectoral approaches
