### 1. ABOUT US

The European Health and Digital Executive Agency (HaDEA) was established by Commission Implementing Decision (EU) 2021/173 of 12 February 2021. Located in Brussels, the Agency comprises three departments and 10 units. Our colleagues are international experts and specialists in matters related to health, food, digital, industry, space, communication and finance.

We currently manage the following programmes on behalf of the European Commission:

- EU4Health programme.
- Horizon Europe: Pillar II, Cluster 1: Health.
- Single Market Programme: Food safety: health for humans, animals and plants along the food chain and better training for safer food.
- Digital Europe Programme.
- Connecting Europe Facility: Digital.
- Horizon Europe: Pillar II, Cluster 4: Digital, Industry and Space.

The Agency reports to six Directorates-General of the European Commission – Health and Food Safety (SANTE), Research and Innovation (RTD), Communication Networks, Content and Technologies (CNECT), Defence, Industry and Space (DEFIS), Internal Market, Industry, Entrepreneurship and SMEs (GROW) and Health Emergency Preparedness and Response (HERA) – which remain responsible for programming and evaluation.

Unit C.1 of HaDEA – Operational Finance - is placed within the Finance and Resources Department (Department C) of the Agency. The Unit provides financial management and programme support services to the HaDEA operational departments, participating in the whole lifecycle of actions (grants, procurement, prizes, experts and other types of delegated actions) from budget commitment to action preparation, final payment and recovery. The Unit is organised in four programme-specific Sectors as well as cross-sector matrix teams. The Agency's operational budget cell is placed in the Unit and reports directly to the Head of Unit/Deputy Head of Unit. The staffing allocation for 2024 is more than 90 posts, and the Unit is expected to continue growing until the end of the current Multiannual Financial Framework. HaDEA Unit C.1 and its Sectors have an excellent team spirit and are eager to welcome colleagues who seek a challenging, yet very rewarding working environment.

#### 2. JOB DESCRIPTION

We have 10 vacant posts to be filled. The posts are immediately available and currently placed across all HaDEA Unit C.1 Sectors: C.1.1 (Digital Europe and CEF Digital), C.1.2 (HE: Digital, Industry, Space), C.1.3 (EU4Health and Food) and C.1.4 (HE Health), and the Budget Cell – with possible cross-sector work on other programmes during peak workload periods. Specific allocation will depend on matching candidate profile, interest and Unit needs.

We are looking for enthusiastic, highly motivated and well-organised professionals. Sense of initiative, sense of responsibility, ability to work independently, sound judgement, problem solving skills and good team spirit are essential. The role of Financial Officer is focused on the intelligent application of grant and contract provisions, fully supported by IT systems to encode transactions. Therefore, colleagues with varied professional backgrounds and interest in grant and contract management are welcome to apply.

For positions with our Budget Cell, we welcome specific experience in budget planning and reporting.

#### **Overall purpose**

Under the direct supervision of the Head of Sector, the jobholder provides contractual and financial analysis, advice and assistance related to the full expenditure lifecycle of managed actions, emanating from the different programmes implemented by the Agency. In particular, the jobholder prepares and supports the creation of commitments, amendments, payments, forecasts of revenue and recovery orders on the Agency's operational budget lines, ensuring that transactions are procedurally correct, including drafting related contract and financial support documents. The jobholder may also contribute to horizontal tasks in line with the Unit objectives at the request of the Unit's hierarchy.

The jobholder will work in collaboration with the Project Officer on *ex-ante* controls to ensure the conformity of financial operations with legality, regularity, internal procedures and sound financial management. The jobholder will contribute to reporting and monitoring of commitments, expenditures and recoveries and accounting data quality exercises. The work will be performed through corporate IT tools (ABAC/eGrants/other local systems), as appropriate.

Financial Officers placed in the Budget Cell will be in charge of the preparation, monitoring and reporting of the annual and multiannual operational budget, will act as budget planners of the full programme portfolio delegated to HaDEA, will provide advice on budgetary topics in respect of the financial regulations, and will contribute to the set-up of budget-related procedures.

#### Specific Tasks

#### BUDGET, FINANCE, CONTRACTS and ACCOUNTING

- Prepare and follow-up financial transactions (global commitments, individual commitments); support the preparation of the grant agreement, contracts, amendments and perform, as required, financial capacity checks, for the programmes delegated to the Agency.
- Prepare and validate invoices, payments, forecasts of revenue, recovery orders and decommitments, ensuring that they are financially and procedurally correct, in conformity with the grant agreement/contract, the Financial Regulations and within the specific legal deadlines.
- Give visa of Financial Initiation in ABAC, where appropriate, and/or the visa of a support officer in eGrants/eProcurement/eExpert workflows.
- Support and prepare recovery, enforced recovery and waiver files.
- Provide advice and technical support to staff, as well as to external stakeholders, at the different steps of the lifecycle of an action (selection, GAP / contract preparation, amendment and closing of grant agreements, commitments, payments, ex-post audit implementation, recoveries) in order to solve specific financial issues and to ensure financial viability.
- Contribute to the development and implementation of harmonised procedures, norms and methods to process and access financial information.
- Prepare replies to requests for information from the hierarchy and other services within the Agency and across the Unit (such as accounting quality/budget forecast exercises) and follow-up of other financial horizontal tasks as assigned (such as reporting, audit liaison, budget correspondent, internal control, anti-fraud, pre-litigation support functions, as well as occasional financial verification tasks).

#### INFORMATION and DOCUMENT MANAGEMENT

- Ensure appropriate document management and follow-up.
- File financial documents and correspondence linked to daily operations according to filing rules and corporate/Agency's procedures.
- Ensure quality and coherence of financial and contractual data in-between different databases.

#### AUDIT, CONTROL and INSPECTION

- Provide assistance for "on the spot" control and audit missions.
- Assist in the collection of the necessary information for audit and control by the Commission's services or the European Court of Auditors.
- Follow up and implement any financial findings of audited actions.

#### BUDGET and FINANCE (operational) / PLANNING & MONITORING

- Prepare and revise the forecast of the operational budget delegated to HaDEA (annual and multiannual budget) during the periodic budgetary exercises, preparing and keeping the relevant documentation for the hierarchy, the Steering Committee, and the Parent DGs.
- Overall planning and monitoring the commitments and payment consumption of the voted budget delegated to HaDEA using the European Commission's financial system (ABAC/SUMMA), the Financial Reporting Catalogue, Business Object Data Warehouse (ABAC/SUMMA and Corda).

#### 3. PROFESSIONAL QUALIFICATIONS AND OTHER REQUIREMENTS

#### A. Eligibility criteria<sup>2</sup>:

To be considered eligible, candidates must satisfy all the following eligibility criteria by the closing date for submitting applications:

- 1. Be in the same Function Group as the one of the published  $post^3$ .
- 2. Have served at least three years as contract agent 3(a) or  $3(b)^4$ .
- 3. Have successfully passed an EPSO CAST selection for that same Function Group<sup>5</sup>.

All Contract Agents 3(a) and 3(b), fulfilling eligibility criteria, currently employed can apply. However, priority will be given to CA 3(a). If there are no successful CA 3(a) applications, Contract Agents' 3(b) applications will be considered.

Please note that only candidates engaged by the Executive Agencies, European Commission in its departments, administrative offices, representations and EU Delegations, EPSO, OP and OLAF<sup>6</sup>, who comply with all the eligibility criteria, will be considered for further steps of this selection procedure<sup>7</sup>.

### **B.** Selection criteria

#### Essential

- 1. Candidates must have acquired at least 1 (one) year of professional experience in the financial or budget field, performing some of the functions and duties described in the point 2. ("Job description") of the current Vacancy Notice.
- 2. Very good oral and written command of English with spoken and written skills equivalent to level C1<sup>8</sup> or higher level for working purposes (very good, excellent, fluent, advanced, proficient, native, or similar).

#### Advantageous

- 1. Demonstrated and proven knowledge (by experience and/or training) of the EU Financial Regulations and/or EU funded spending programmes.
- 2. Demonstrated and proven work experience in applying rules and procedures linked to the preparation of grants and/or procurement contracts, or equivalent instruments.
- 3. Demonstrated and proven work experience in applying rules and procedures linked to the assessment (*ex-ante* or *ex-post*) of the eligibility/conformity of underlying costs of grants and/or procurement contracts, or equivalent instruments.
- 4. Demonstrated and proven experience working (through experience and/or training) with IT tools that are used to manage financial/accounting/budget/legal processes (e.g., EU grant management tools/SAP/Excel/other tools).
- 5. Demonstrated and proven (by experience and/or training) experience in budget preparation and/or experience in using forecasting tools (e.g. BadgBud, DG BUDG Forecast tool, R&I Hearings/Forecast, other DG-specific tool etc.); experience in budget planning in eGrants is considered particularly advantageous.
- 6. Post-secondary education diploma in the field of finance, economics, accounting or law.

#### Interpersonal competencies:

- Sense of initiative, critical thinking, excellent problem-solving skills and analytical capabilities.
- Good organisational and planning skills, ability to work under pressure and within tight deadlines.
- Excellent communication skills, both orally and in writing.
- High sense of responsibility, discretion and confidentiality and capacity to work autonomously.

Candidates need to explicitly describe and substantiate in their applications to what extent they meet the above-mentioned selection criteria (essential, advantageous). In particular, they

need to explain in their applications (i) how their professional experience and knowledge relates to the job description outlined in this vacancy notice and (ii) how long and where the professional experience and knowledge were acquired during their career.

## 4. SELECTION PROCEDURE

### A. Eligibility checks

First, HaDEA People Sector, on behalf of the Selection Committee will check the submitted applications against the eligibility criteria (point 3.A). Only eligible applications will be assessed further.

#### **B.** Assessment of eligible applications

The Selection Committee will analyse the applications (which comprise of motivation letters and CVs) of eligible candidates with reference to:

- The selection criteria ("Professional qualifications and other requirements" point 3.B, under points "Essential" and "Advantageous"),.
- The overall assessment of the quality and suitability of the application based on the requirements of the post.

Submitted applications, that do not meet one or more of the essential selection criteria (see point 3.B "Selection criteria"/ "Essential"), or applications, which do not include both motivation letter and CV, will not be evaluated further.

Upon completion of the assessment, the Selection Committee will establish a shortlist of preselected candidates matching best the needs of the Agency for the functions and duties mentioned in this Vacancy notice, who will be invited to the next phase of the selection procedure.

## C. Interview

Shortlisted candidates will be invited for an interview (duration: +/- 30 minutes, main language of the interview: English).

The interview will assess skills and competences related to the job description and selection criteria under point 3.B of this Vacancy notice. Candidates scoring less than 60% of the total score of the interview will not be considered further.

## 5. SELECTION COMMITTEE

A Selection Committee will be appointed for this selection procedure and will be composed of at least four members, including a member designated by the Staff Committee to represent staff.

The names of the members of the Selection Committee will be communicated to candidates upon notification of the outcome of the assessment of eligible applications (see point 4. "Selection Procedure", "Assessment of eligible applications").

However, under no circumstances should candidates approach the Selection Committee

**members**, either directly or indirectly, **concerning this selection procedure**. Candidates doing so will be immediately disqualified from the selection process.

## 6. APPLICATION PROCEDURE

To apply for this position, and for the application to be valid, candidates must submit:

- A detailed curriculum vitae, in Europass format<sup>9</sup>.
- A letter of motivation, including his/her views on the proposed position (1 page maximum).

There is no obligation to submit applications in English, however documents sent in English will greatly facilitate the work of the Selection Committee.

Applications must only be sent via email to the functional mailbox <u>HADEA-TALENT-SELECTION@ec.europa.eu</u> no later than 27/03/2024 (new extended deadline), 12:00/noon CET Brussels time.

The Agency strongly advises not to wait until the last few days before the deadline for applying, since heavy internet traffic or connection difficulties could lead to problems. **Under no circumstance will late applications be accepted.** 

It is the sole responsibility of each applicant to complete the application and to submit it before the deadline for submission. Any information or documentation provided after the deadline will not be taken into account.

A candidate will be disqualified if:

- the candidate does not submit the complete application by the deadline.
- at any stage in the procedure it is established that information the candidate provided is incorrect or false, or that the candidate made declarations unsupported by the appropriate documents.
- the candidate failed to inform the HaDEA People Sector of the Agency of a possible conflict of interest with a Selection Committee member.
- the candidate attempted to contact, or contacted, a member of the Selection Committee either directly or indirectly concerning this recruitment procedure.
- the candidate failed to attend the interview.

Candidates are also required to inform the HaDEA People Sector (<u>HADEA-TALENT-SELECTION@ec.europa.eu</u>) in case there are any relatives (of the candidate) working currently or applying at HaDEA.

Candidates are invited to indicate in their communication with the HaDEA People Sector any special arrangements that may be required if invited to attend an interview.

### 7. EQUAL OPPORTUNITIES

The European Union institutions apply a policy of equal opportunities and accept applications without discrimination on the ground of sex, race, colour, ethnic or social origin, genetic features, language, religion or belief, political or any other opinion, membership of a national minority, property, birth, disability, age or sexual orientation.

#### 8. APPOINTMENT AND CONDITIONS OF EMPLOYMENT

The successful candidate will be recruited as contract staff in Function Group III under the terms of Article 3a of the CEOS and the Commission Decision C(2017)6760 of 16.10.2017 on the general provisions for implementing Article 79(2) of the Conditions of Employment of Other Servants of the European Union, governing the conditions of employment of contract staff employed by the Commission under the terms of Article 3a and 3b thereof which is applicable to HaDEA by analogy pursuant to Decision of the Steering Committee of the Health and Digital Executive Agency SC01(2021)06 of 26 February 2021.

At the request of HaDEA, the selected candidates will have to evidence with supporting documents the information contained in their application.

For successful candidates in Function Group III under the terms of Article 3b, a reassessment of their grade will be done at recruitment and **might impact their current grading (that might turn into an upgrade, a downgrade or keeping their current grade).** In order to manage realistic expectations in this sense, it is strongly recommended to refer to Article 5 of the above-mentioned Commission Decision for classification in the function group at entry into service.

#### 9. REQUEST FOR REVIEW

The candidate can request a review of any decision taken by the Selection Committee that established the results and/or determines whether a candidate can proceed to the next phase of the selection procedure or is excluded.

Requests for review can only be based on:

- a material irregularity in the selection procedure process; and/or
- non-compliance, by the Selection Committee, with the Staff regulations, the Vacancy notice and/or case law.

This request must be made within 10 working days of the date of the e-mail notifying the candidate of the outcome of the selection procedure<sup>10</sup>. The request should quote the reference number of the selection procedure concerned, the name of the candidate and the phrase "request for review" in the subject of the e-mail. During the review, the Selection Committee can only take into consideration information contained on the candidate's application (including CV and motivation letter) at the deadline for submission. Any additional information or documentation provided after that deadline will not be considered. The Selection Committee will acknowledge receipt of the request submitted, assess the request and notify the candidate of its decision within 15 working days of receipt of the request.

It should be noted that candidates are not allowed to challenge the validity of the Selection Committee's assessment of the quality of their performance during an interview and/or written test, or of the relevance of their qualifications and professional experience. This assessment is a value judgement made by the Selection Committee and their disagreement with the Selection Committee's evaluation of their performance during an interview and/or written test, or the relevance of your qualifications and professional experience, does not prove that an error was made. Requests for review submitted on this basis will not lead to a positive outcome.

#### **10. APPEAL PROCEDURE**

Pursuant to Article 90(2) of the Staff Regulations of Officials of the European Communities ("Staff Regulations"), any candidate may submit to the to the AECE (i.e., the Director of the Agency) a complaint against a decision, or lack thereof, that adversely affects them, if they believe that the rules governing the selection procedure have been infringed.

1. Administrative complaints

Administrative complaints must be lodged within three months from the date on which the candidate is notified of the act adversely affecting them. The complaint should quote the reference number of the selection procedure concerned, the name of the candidate and the phrase "Administrative Complaint" or "Article 90" in the subject of the email. Any such complaint should be addressed to the AECE of HaDEA and sent to the following email address: <u>HADEA-TALENT-SELECTION@ec.europa.eu</u>.

The AECE cannot overturn a value judgement made by the Selection Committee. The AECE shall notify the person concerned of its reasoned decision within four months from the date on which the complaint was lodged.

2. Judicial appeal

Candidates may submit a judicial appeal of the act adversely affecting them pursuant to Article 270 of the Treaty on the Functioning of the European Union and Article 91 of the Staff Regulations. #### 3. European Ombudsman

Candidates can lodge a complaint to the European Ombudsman within two years of the date when they become aware of the facts on which the complaint is based. Before submitting such complaint, the candidate must first make the appropriate administrative approaches to the institutions and bodies concerned (see above). Making a complaint to the Ombudsman does not extend the deadlines for lodging administrative complaints or judicial appeal.
